\* Empowering local leaders to share the Gospel, reduce poverty, and create self-sufficiency for every child.

\* Equipping partnering communities to directly engage in healthy, international development practices.

Annually, officers and board members sign a conflict of interest statement.  
The finance committee reviews significant transactions throughout the year.  
The President/CEO and Controller regularly and consistently monitor and  
enforce compliance with the conflict of interest policy. Should any  
potential conflicts of interest be disclosed, the board member or officer  
would be asked to refrain from participation in any deliberation or  
decision with regard to matters affected by the relationship.
